

## 2026 AffirmedRx Choice Formulary Changes

AffirmedRx will update its drug lists **effective January 1, 2026**. These updates may include the following types of changes:

- Formulary to Non-Formulary: These drugs are no longer preferred by your health plan. If there is a clinical reason identified by your doctor or health care provider that requires you to continue taking your current medication, your doctor can submit a prior authorization request to obtain approval for the medication.
- Non-Formulary to Formulary: These drugs have been added to the formulary. Additional requirements may apply.
- Excluded Drugs: These drugs are no longer covered by your prescription benefit plan.
- Tier Changes: Drugs that remain covered but may move to a higher (up-tier), or lower (down-tier) tier. Your out-of-pocket costs may change.
- Utilization Management Updates: Certain medications may now require prior authorization, step therapy, age or quantity limits
- *Additional requirements may apply to the medications listed in this document. This includes but is not limited to Step Therapy, Quantity Limits, or Prior Authorization. Please scan the QR code below for a full listing of covered medications and associated edits.*
