APPROVAL CRITERIA

Initial requests for Letairis (ambrisentan) may be approved if the following criteria are met:

- I. Individual has pulmonary arterial hypertension (PAH) [World Health Organization (WHO) Group 1]²; **AND**
- II. Individual has a right-heart catheterization showing all of the following (Hoeper, 2013; Ivy, 2013; Abman, 2015):
 - A. Mean pulmonary artery pressure (mPAP) greater than or equal to 25 mm Hg at rest;
 - B. Pulmonary capillary wedge pressure (PCWP), mean pulmonary artery wedge pressure (PAWP), left atrial pressure, or left ventricular end-diastolic pressure (LVEDP) less than or equal to 15 mm Hg;
 - C. Pulmonary vascular resistance (PVR) greater than 3 Wood units; AND
- III. Individual has WHO functional class II-IV³ symptoms.

Continuation requests for Letairis (ambrisentan) may be approved if the following criterion is met:

I. There is clinically significant improvement or stabilization in clinical signs and symptoms of disease (including but not limited to improvement in walk distance, dyspnea and/or functional class).

Requests for **brand** Letairis must also meet the following criteria, in addition to the above Prior Authorization criteria:

- I. Documentation is provided that individual has failed an adequate trial (medication samples/coupons/discount cards are excluded from consideration as a trial) of one chemically equivalent generic ambrisentan agent; **AND**
 - A. Generic ambrisentan had inadequate response; OR
 - B. Generic ambrisentan caused adverse outcome; **OR**
 - C. The individual has a genuine allergic reaction to an inactive ingredient in generic

agent. Allergic reaction(s) must be clearly documented in the individual's medical record.

Letairis (ambrisentan) may **not** be approved for the following:

- I. Individual has a diagnosis of idiopathic pulmonary fibrosis (IPF); OR
- II. Individual has a diagnosis of moderate (Child-Pugh Class B) or severe (Child-Pugh Class C) hepatic impairment; **OR**
- III. Individual is on dialysis or has a diagnosis of severe renal impairment (creatinine clearance less than 20 mL/min); **OR**
- IV. In combination with other endothelin receptor antagonist (ERA) agents, such as but not limited to Opsumit (macitentan) or Tracleer (bosentan); **OR**
- V. Individual is initiating therapy and has a diagnosis of clinically significant/severe anemia.

Notes:

- Letairis (ambrisentan) has a black box warning for embryo-fetal toxicity. Letairis is very likely to produce serious birth defects if used by pregnant women, as this effect has been seen consistently when it is administered to animals. Pregnancy must be excluded before the initiation of treatment and prevented during treatment with acceptable methods of contraception. Monthly pregnancy tests should be obtained during treatment and 1 month post-treatment. Because of the risks of birth defects, Letairis is available for females only through a special restricted distribution program under a Risk Evaluation and Mitigation Strategy (REMS)..
- 2. WHO Pulmonary Hypertension (PH) Group Classification (ACCF/AHA 2009):
 - A. Group 1: Pulmonary arterial hypertension (PAH)
 - B. Group 2: PH due to left heart disease
 - C. Group 3: PH due to lung diseases and/or hypoxia
 - D. Group 4: Chronic thromboembolic PH (CTEPH)
 - E. Group 5: Miscellaneous/PH with unclear multifactorial mechanisms
- 3. WHO functional classification of PH (CHEST 2019):
 - A. Class I: No limitation of physical activity. Ordinary physical activity does not cause undue dyspnea or fatigue, chest pain, or near syncope.
 - B. Class II: Slight limitation of physical activity. Comfortable at rest but ordinary physical activity causes undue dyspnea or fatigue, chest pain, or near syncope.
 - C. Class III: Marked limitation of physical activity. Comfortable at rest but less than ordinary activity causes undue dyspnea or fatigue, chest pain, or near syncope.
 - D. Class IV: Inability to carry out any physical activity without symptoms. Dyspnea and/or fatigue may be present at rest and discomfort is increased by any physical activity.
